## Ideas from 2017 Chapter Excellence Reports:

# **Charity and Service**

Orion Chapter #12 (District 1) and Orion Lodge collaborate to provide a safe **Halloween** experience for children in the surrounding area. Hot dogs, hot chocolate and candy were offered to ghosts and goblins of all sizes, at no charge. A "tip jar" attracted donations of \$88 for Special Olympics.

Palmy Chapter #114 (District 2) provides \$200 "start-up kits" for high school students entering the county's **vocational school**. This past year, funding was provided for four students and the awards were presented at the high school awards ceremony.

Brecksville Chapter #537 (District 3), made "**twiddle muffs**" for residents of the Ohio Eastern Star Home. The knitted or crocheted muffs are embellished with a variety of tactile objects that help persons with memory issues keep their hands and fingers busy and warm.

Home City Chapter #258 (District 18) makes "Fidget Quilts" for persons with dementia or Alzheimer's. The quilts are donated to the Eastern Star and Masonic Homes.

Guernsey Chapter #211 and District 15 collected nearly 5,000 new or gently used books for local elementary schools and the Scottish Rite Children's Learning Center.

Freeport Chapter #319 (District 14) raised \$2,000 at a **Cystic Fibrosis benefit dinner** in honor of the daughter of a member.

Several chapters have "adopted" residents of the Ohio Eastern Star Home and Masonic Home, and treat them with cards, gifts and visits.

Medina Chapter #266 teamed up with Medina Lodge to sponsor a **Little League baseball team**. They provided funds for uniforms and equipment. The chapter and lodge also hosted an opening day tailgate party and an end-of-the-season celebration banquet for the players and their families.

Shreve Chapter #496 (District 4) sponsored a **t-shirt, socks and underwear drive** for the Christian Children's Home of Ohio in Wooster.

Several chapters around the state are involved with Project Linus, making no-sew fleece blankets for children in need.

Triune Chapter #344 (District 6) held a **diaper drive** to benefit needy families, in memory of the infant son of a Triune member. The disposable diapers and baby wipes were delivered to the Otsego Food Pantry.

Spencerville Chapter #130 (District 8) collaborates with the Spencerville Masons to provide a spaghetti dinner at the Temple for **high school football players** and cheerleaders before their home games.

Stokes Chapter #543 (District 9) and Stokes Lodge provided a Memorial Day **breakfast for the Boy Scouts and 4-H members** who were decorating the graves at Glen Cemetery with flags. The youth were invited back to the building for cookies and milk.

East Palestine #381 (District 13) has a **Sharing & Caring Fund** for members in need. They gave Walmart and restaurant gift cards to some Sisters and Brothers at Christmas time, and also extended financial assistance to a Sister whose husband was hospitalized.

Active members of Louisville Chapter #400 (District 13) select the name of a member who is homebound and remember them with cards, gifts and visits throughout the year.

Woodsfield Chapter #268 (District 15) held a sub sale to **raise money for clothing and toys for needy children.** They distributed flyers to local businesses and offered free delivery. Funds were used to shop for clothing and toys for 48 children. Members also wrapped the packages for Christmas.

Laura Chapter #264 (District 16) sponsors an annual **Holiday Craft Day for childre**n ages 4-10. Three chapter members were instructors/helpers, along with three high school students who used the time for service hours. A fee of \$10 per child was charged. Since all materials were donated, it ended up being a fund-raiser for the chapter.

Olivet Chapter #538 (District 18) prepared and delivered "**First Responder Survival Kit**" treat bags to firemen and deputies in area fire and sheriff departments, along with a certificate of appreciation.

Dayton-Victory Chapter #594 (District 19) gave its members **Christmas stockings** at the November meeting and asked them to fill them and bring them back in December. The filled stockings were taken to The Eastern Star Home in Mount Vernon for distribution to residents.

Prosser Chapter #367 (District 19) put up an **angel tree** at the November chapter meeting. Suggested gifts for members of a needy family were written on the paper angels that decorated the tree. Members were asked to pick one,shop for the requested items, and bring them back in December. The chapter also collected food items and provided gift cards for the family.

Washington Chapter #195 (District 19) prepared a **dessert reception for the Council inspection** in its lodge building and also **entertained the wives** with homemade card-making while the men were in their meeting.

Marietta Chapter #59 (District 25) provides a **"Third Sunday Luncheon"** every month, to serve a hot meal to low-income individuals and families. The free meals are served with regular plates and silverware and tables feature seasonal decorations so that those attending can dine in pleasant surroundings.

Reber Chapter #161 (District 27) hosted a beef stew fund-raising dinner to **benefit the local food pantry**. They worked with food distributors to arrange for discounts and donations. Members donated desserts as well as cooking and serving the dinner, which was open to the public.

## **Social Activities and Fellowship**

The secretary of Billow Chapter #483 (District 2) prepares **history reports** for chapter members, detailing date of initiation as well as those participating in the initiatory work, offices held and other activities the member was involved in. The report is read during the presentation of membership pins. If members are unable to make it to chapter, due to health or distance, the History Report is sent or delivered to them, along with their pin. A nice personal touch!

Ravenna Chapter #46 (District 2) and Dayton-Victory Chapter (District 19) sponsor **golf outings** as fundraisers, social events and/or charitable endeavors. Ravenna's June event, raised more than \$1,000 to benefit those involved in research and support programs for victims of Parkinson's Disease.

Anne Rutledge Chapter #453 (District 3) has a monthly **"Around The Town" dinner group**. Members take turns selecting the restaurant, publicizing the place and menu, and taking reservations.

Several chapters (Brecksville #537, Medina #266, Triune #344, etc.) held painting parties.

The River Chapter #517 (District 3) had a **Sunday afternoon spa day** at a hair and nail salon operated by one of its members. Refreshments were served and even men participated!

Stokes Chapter #543 (District 9) invited their **ESTARL recipient to be a speaker for Friendship Night**. He told how he had come to the U.S. from the Phillipines, and his daughter sang songs.

A Friendship Night program featured a comic **Initiation Ceremony of the Order of Eating Sisters.** The five "degrees" were: Appetizers, Beverages, Entrees, Green Vegetables, and Just Desserts.

Greenwood Chapter #159 (District 6) opted to not have **Friendship Night** at a meeting, but instead invited its Sister Chapter to Snooks Car Museum in Bowling Green, followed by a pot luck dinner.

Worthy Matrons of several chapters print out **copies of their agenda for the Secretary**, Associate Matron, and Line Officers.

Members of Windermere Chapter #388 (District 3) hold a **Sunday brunch Grand Chapter Send-off** for the Worthy Matron and Worthy Patron. Officers also provide a monetary donation to help the presiding officers with Grand Chapter expenses.

# **Membership and Public Relations**
